'Sea-Level Rise and International Law: Protection of Persons Issue' Monday 23th May 2022

Geneva Academy of International Humanitarian Law and Human Rights

BACKGROUND

In May 2019 the International Law Commission (ILC) decided to include the topic "Sea-level rise in relation to international law" in its current programme of work and to establish an open-ended Study Group on the topic, to be co-chaired, on a rotating basis, by Bogdan Aurescu, Yacouba Cissé, Patrícia Galvão Teles, Nilüfer Oral and Juan José Ruda Santolaria.

A <u>first issues paper</u> on topics dealing with law of the sea was presented and discussed by the ILC in 2021, while the Commission also received some information submitted by States and International Organisations in 2021 and 2022 (for information see the ILC analytic guide).

In May and July 2022 the ILC will consider the <u>second issues paper</u> elaborated by Prof. Patrícia Galvão Teles and Prof. Juan José Ruda Santolaria dealing with the statehood and protection of persons affected by sea-level rise issues.

In view of the relevance of this topic and to stimulate further analysis on current analysis and the future activities of the ILC in this area, the Geneva Academy of International Humanitarian Law and Human Rights, in cooperation with the <u>Law Department, Roma Tre University</u>, and the <u>Yearbook of International Disaster Law</u> has decided to host a selected group of experts from academia, civil society, international organizations and governments, for a frank and engaging discussion. In particular, the expert meeting will focus on the sections of the second issues paper presented to the ILC in 2022 and elaborated by Prof. Patrícia Galvão Teles devoted to protection of persons issues (Part III and Part IV.I.B of the <u>second issues paper</u> devoted to protection of persons affected by sea-level rise), in particular on issues addressing

identification of relevant legal regimes and relevant practice by States and International organisations related to the protection of persons affected by sea-level rise with a specific reference to human rights, displacement, and cooperation. To facilitate the discussion, a specific attention will be put to questions addressed in Part IV.I.B, para. 435 of the <u>second issues paper</u> (reproduced below in the section 'Meeting Documents).

This expert meeting will be a small, intimate event with around 25 guests, at which participation will be by invitation only, to promote a robust exchange of views on the 2022 Report. Chatham House rules will apply.

Some academics will be requested to briefly introduce a section of the report (max. 12 minutes) to provide with a first critical evaluation on the topic. Subsequently the floor will be opened for discussions by participants to focus on positive aspects and potential shortcomings of the current analysis. In particular in order to provide inputs for future activities by Prof. Patrícia Galvão Teles and the ILC on such issues, it would be helpful to identify priorities of issues for International Organisations, States, and relevant stakeholders, discuss further steps and ways to collectively contribute on future activities. Participants are highly recommended to engage in a frank and vibrant discussion of the different topics.

Some notes on this event summarising positions and discussion held, taking into account the Chatman House rules characterising this event, might eventually be elaborated. Consequently, neither the identity nor the affiliation of the speakers will be connected to comments made. Working language: English.

As mentioned above, during the discussion specific attention will be devoted to questions raised in Part IV.I.B, para. 435 of the <u>second issues paper</u>, namely:

"Taking the 2018 syllabus into account (A/73/10, annex B, para. 17), and starting from the recognition that territorial States have the primary duty and responsibility to provide protection and assistance to persons within their jurisdiction, the following issues may be studied further and in more detail in order to identify and develop principles regarding the protection of persons affected by sea-level rise:

- (a) what principles are applicable or should be applicable to the protection of the human rights of persons affected by sea-level rise? In particular, what are or should be:
- (i) the substantive obligations of States to respect human rights with regard to the right to life, the prohibition of cruel, inhuman or degrading treatment, the right to adequate housing, the right to food, the right to water, the right to take part in cultural life and respect for cultural identity, the right to a nationality and the prevention of statelessness, the rights of children, the right to self-determination and the rights of indigenous peoples;
- (ii) the procedural obligations regarding public participation, access to information and access to justice;
- (iii) the *non-refoulement* obligations for third States;

- (iv) the obligations regarding the protection of vulnerable persons and groups (including women, children and indigenous peoples);
- (v) the obligations regarding the prevention of risks affecting persons?
- (b) what principles are applicable or should be applicable to situations involving the evacuation, relocation, displacement or migration of persons, including vulnerable persons and groups, owing to the consequences of sea-level rise or as a measure of adaptation to sea-level rise? In particular, with regard to displacement and human mobility, what are or should be the obligations of States to protect and assist persons affected by sea-level rise, adopting both a rights-based and a needs-based approach, in the following areas:
- (i) prevention of displacement;
- (ii) assistance to remain in situ;
- (iii) establishment of principles for planned relocation;
- (iv) protection of persons in case of internal displacement and promotion of durable solutions;
- (v) protection options in case of cross-border displacement (such as humanitarian visas or temporary protection schemes);
- (vi) arrangements for regular migration (both temporary and long-term);
- (vii) the granting of refugee status or complementary protection if existing criteria are met?
- (c) what is or should be the applicability and scope of the principle of international cooperation by other States, in the region and beyond, and by international organizations, to help States with regard to the protection of persons affected by sea-level rise?
