



Call for Student Mobility

PNRR - PNRR TNE TRANSIT Project CUP: E63C24001340007

Roma Tre University is proud to invite applications for the PNRR TNE TRANSIT Project Student Mobility Program. This initiative, funded by the Italian National Recovery and Resilience Plan (PNRR) and the European Union's NextGenerationEU, aims to enrich educational and research opportunities through international collaboration and mobility. We seek to integrate teaching methodologies and foster academic exchanges across diverse socio-cultural environments, particularly focusing on regions in South America and the Far East.

Conditions provided by this call for application may be modified or be subject to integrations, according to the publication of the Guidelines for Reporting on the PNRR TNE- project issued by the Ministry of Universities and Research (MUR):

Eligibility and Requirements:

- Open to students enrolled at any of the partner institutions within the TRANSIT network:
 - Roma Tre University (Italy)
 - Universidad Nacional de Tres de Febrero (Argentina)
 - Universidade de São Paulo Faculdade de Filosofia, Letras e Ciências Humanas (Brasil)
 - Nankai University (China)
- The mobility opportunities must adhere to the following criteria: students from Roma Tre University can only undertake mobility at a foreign university, while students from foreign partners must do mobility at Roma Tre University.
- Eligibility for this selection notice includes students enrolled in first, second, or third-cycle degree (Doctoral) programs.
- Students currently participating at the host university via other mobility grants are also eligible. Activities and funding under this program will commence after the conclusion of the other program and its financial support.

Mobility Details:

- The mobility can start from 01/05/2025
- Mobility must be completed by February 28, 2026.
- Permitted activities during the mobility abroad include:
 - Attending courses and workshops;
 - Participation in ongoing assessments and/or final exams;
 - Research aimed at thesis preparation;
 - Laboratory activities;
- The program supports stays of 2 or 3 months, with scholarships covering travel, accommodation, and living expenses:
 - €5,000 for a two-month stay.
 - €7,000 for a three-month stay.



- An advance payment of €1,000 is provided to facilitate initial expenses.
- Students will have access to all services and facilities typically available to regular students at the host institution.
- Tuition and other course-related fees will be waived for participants. Students must cover any additional expenses not included in the scholarship.
- Each institution in the TRANSIT network must ensure that its students have adequate accident and civil liability insurance during their mobility, in line with Italian or local legislation.
- Health insurance is not provided; students are required to arrange their own medical coverage for the mobility period
- If the mobility period is shorter than the minimum limits, participants must repay the entire advanced grant.
- Participants must repay any excess if the advance payment exceeds the total grant calculated for the actual mobility period. An email with repayment instructions will be sent to the participant.
- Participants failing to pass at least one of the exams listed in the Learning Agreement or its Amendment are required to return the financial support received.
- Participants must submit a comprehensive report describing in detail their experiences and learning outcomes. Failure to submit this report will result in the repayment of any financial support received.
- The financial support provided by the PNRR/TNE TRANSIT international mobility project can be combined with other grants from regional authorities or entities, provided these funds are not sourced from European programs, adhering to regulations against double funding.

Application and Selection Process:

- Applications must be submitted through the partner universities by May 5th, 2025.
- The selection process will involve a review of academic merit, language proficiency, and motivation.
- Two selection committees (one at Roma Tre and one at the partner institution) will oversee the process, ensuring transparency and equity.
- The host university will contact the candidates to provide the final confirmation of acceptance and inform candidates of the enrolment procedures.

Scholarship and Benefits:

- Comprehensive scholarships as detailed above.
- Tuition and fees at the host institution will be waived.
- Participants will gain academic recognition for courses and activities undertaken during the mobility.

Important Dates:

- Program start date: Anytime before the stipulated end date of February 28, 2026.
- Application submission deadline: May 5th, 2025.

Application Documents Required:

- Motivation Letter max. 8000 characters.
- Proof of Enrollment



- Academic Transcripts
- Language Proficiency Certificates or official proof of language exams successfully completed.

Evaluation Criteria:

- Academic Record and Achievements
- Relevance of the Study Plan to the Student's Career Goals
- Language Skills
- Motivational Statement
- Priority is given to candidates from linguistic, religious, or other cultural minorities;
- Efforts will be made to ensure gender balance. An equal number of candidates from both genders will be admitted. Any remaining position will be reassigned based on the overall ranking.

Additional Information:

- Students are required to secure their own health and travel insurance for the duration of their mobility.
- For extracurricular activities, the student must submit a document detailing the type of activity to be undertaken, and upon completion, a certificate of participation will be issued.

Deadline for application: **The application period is open-ended and will continue until funding is depleted.**

The decision of the selection committee, based on its discretionary evaluation, is final and cannot be reviewed.

Please note: The candidate is entirely responsible for filling out the application form. Applications that are not completed online before the deadline will be considered void. Applications containing incorrect or untrue data will be void as well. It will not be possible to subsequently modify or cancel the applications already submitted.

INSTRUCTIONS FOR VISAS

Immigration laws and regulations for non-EU students in the countries participating in the Programme vary depending on the student's nationality. Therefore, each student is responsible for gathering information from the relevant diplomatic offices in a timely manner and for obtaining the necessary documents to enter and stay in the host country.

Students must:

- ✓ Check the website of the Italian Ministry of Foreign Affairs and International Cooperation for updates regarding safety and potential travel risks in the host country: <https://www.viaggiare Sicuri.it>;
- ✓ Familiarize themselves with and accept the conditions of mobility at their host university;
- ✓ Purchase travel insurance covering delays or cancellations caused by epidemics, pandemics, or other force majeure events;
- ✓ Obtain information regarding visa requirements for the host country;
- ✓ Inquire about healthcare services in the host country by contacting local health
