

## CALL FOR STATEMENT OF INTEREST (unofficial translation)

Art. 7, paragraph 5 bis, Law 30-12-2010, n. 240

The Department of Law of the Università Roma Tre -as part of its objectives of training attentive to the needs of the legal professions and the practice of law in particular- intends to fill a position for Full Professor (*Professore Ordinario*) in Criminal law (*Diritto penale*), s.s.d. Ius/17, for the fulfilment of a didactic project that integrates, in a critical key, classical dogmatics and the reality of the Special Part of Criminal law, also in the light of the applicative-processual dynamics of the so-called 'living law' (*diritto vivente*).

Specifically, the Department intends to involve the applicant(s) who will be selected as a result of this procedure in the following activities:

- Institutional courses in criminal law (SSD IUS/17);
- Courses at the School for Legal Professions and at professionalizing Master's programs;
- Legal clinics
- National and international research projects on the topics listed above.

Applications are solicited from scholars who meet the requirements of Art. 7, paragraph 5 bis, l. Dec. 30, 2010, no. 240 ("Universities may proceed to the call of full and associate professors in service for at least five years at other universities in the bracket corresponding to that for which the selection is announced, or of scholars permanently engaged abroad in research or teaching activities, who have held for at least five years at foreign universities an academic position that is equivalent on the basis of tables of correspondence defined and updated every three years by the Minister of Universities and Research, after consultation with the National University Council, through the carrying out of selective procedures regarding the correspondence of the project proposals presented by the candidate to the teaching, research or third mission needs expressed by the universities. For the call of full professors under the first period, candidates are required to meet the requirements of the regulations in force for aspiring commissioners for the procedures of National Scientific Qualification, referred to in Article 16.")

Applicant(s) must have a significant record of publications in SSD IUS/17 have participated in national and/or international research projects, and demonstrate extensive knowledge and/or experience in the relationship between criminal law and trial. They must also have taught at university institutions other than their own.

Financial treatment, Teaching load and legal regime will be regulated according to current Italian law, as well as by the regulations of the University of Roma Tre and the Department of Law. Interested persons serving in non-Italian universities are invited to check pension and social security profiles.

The lecturer who will be selected by special committee will also have to teach within the master's degree program in Law. Knowledge of the Italian language is required for this purpose.

Expressions of interest can be written in Italian or in English and must contain: *a*) a project proposal explaining the scientific profile, teaching methodologies and research lines of the candidate (maximum 1500 words); *b*) curriculum vitae and list of publications; *c*) statement in lieu of certification (art. 46 d.p.r. December 28, 2000, no. 445) regarding the possession of the requirements provided by art. 7, paragraph 5 bis, l. December 30, 2010, no. 240.

Expressions of interest must be submitted, electronically, **no later than 12.00 on 22 May 2023** to the following pec address: <u>giurisprudenza@ateneo.uniroma3.it</u>

The submission of the application is valid only for the purpose of the expression of interest of this notice and does not entitle, in any case, to admission to the procedures for access to the qualifications of the teaching staff of the University of Roma Tre.
