TITLE OF THE RESEARCH PROGRAMME OF THE GRANT Impacts of invasive alien plant species in Italy: inventory, spatialization and quantification

#### DESCRIPTION OF THE GRANT RESEARCH PROGRAMME

The research program of the two-year post-doc grant focuses on activity 3 in Node 3 of the NBFC, aimed at inventorying the impacts of invasive species in Italy as well as on forecasting and planning risk maps for the prevention, early detection and rapid response to the entry of harmful alien species at the national level, in protected areas and in endangered habitats. Specifically, the post-doc project will focus on the impacts of invasive alien plants in Italy and plans to address one or several of the following specific objectives (to be agreed with the post-doc based on their skills and own interests): 1) To coordinate a national effort to evaluate the potential impacts of all alien plants registered in Italy by applying the recent IUCN standard protocol EICAT (Environmental Impact Classification of Alien Taxa) and producing a national database; 2) To spatialize these impact scores based on species distribution models and evaluate potential cumulative impacts (risk maps) under current conditions and future scenarios, particularly within protected areas in Italy; 3) Focusing on a selection of particularly relevant alien species, to quantify in the field the impacts on native plant species, on plant communities and on ecosystems (e.g. on other trophic levels, soil microorganisms or pollinators); 4) To monitor temporal trends and impacts of invasion in selected threatened habitats (coastal dunes and/or mountain environments), in the context of climate change (eg collaboration in the MIREN project, Mountain Invasion Research Network).

SCIENTIFIC DISCIPLINARY SECTOR (SSD) OF THE RESEARCH PROGRAMME BIO/03

#### **REQUIRED INTAKE**

The candidate must have documented research experience in the field of invasion biology or nature conservation or in the field of plant ecology. The candidate must be able to manage and analyze large-scale spatial data and/or demonstrate excellent ability to autonomously manage field investigations and the recognition of plant species. They must also demonstrate excellent data analysis skills, preferably with the R statistical software.

ANNUAL GROSS AMOUNT including all fees due by the Administration: **€ 25.000,00**

In all cases of suspension, the payment is immediately interrupted until the date of restart of the activities, certified by the Head of the Department.

In the case of anticipate conclusion of the research activity, the monthly installment will be paid proportionally.

# Art. 2

To participate to the selection, it is mandatory to have achieved:

- a II level degree or a degree obtained according to the system prior to the entry into force of Ministerial Decree 509/99, obtained at an Italian university, or a qualification obtained abroad
- a proven scientific and professional curriculum suitable for carrying out the research activity for which you are competing, possibly certified by the possession of additional research training qualifications or documented and suitable experience for research activity already carried out

Should the Master's Degree have been obtained abroad, the course must be declared equivalent, solely for selection purposes, by the Academic Senate of the University. The candidate must possess the required qualification within the deadline specified in the following paragraph 3, under penalty of exclusion.

### Art. 3

The Committee will define the criteria of the selection before proceeding with the evaluation.

# Art. 5

1. The research grant cannot be awarded to students enrolled in undergraduate, Master, Ph.D. or medical specialization in Italy or abroad, and involves placement on unpaid leave or employee with public administration other than those referred to in point .3 below.

2. Participation in the selection is not allowed for spouses, relatives and akin up to and including the 4th degree of the:

- Teaching staff of the Department which has issued this notice;

- Rector;
- General Director;
- Members of the Board Directors.

- 3. Permanent employees of Universities, Research Institutes or public bodies, the National Institute for New Technologies, Energy and Sustainable Economic Development (ENEA), the Italian Space Agency (ASI) and institutions whose scientific specialization qualification have been recognized as equivalent to a Ph.D pursuant paragraph, of Presidential Decree no. 382 of July 1980, cannot participate in the selection.
- 4. The research grant cannot be combined with any scholarships, except those awarded by national or foreign institutes to supplement research activities of said temporary research fellows with permanence abroad.
- 5. The grant for carrying out research activities is governed by a specific individual contract, based on the following criteria: flexibility in meeting the needs of the activity, continuity, time allocation (not sporadic), coordination with the overall activities of the Department, close relationship with the implementation of a research program, autonomous activity within the scope of the program and absence of pre-determined working hours.

The evaluation of the titles will take place on Monday 06/02/2023 and the interview on Wednesday 14/02/2023 at the Department of Sciences - Viale Guglielmo Marconi 446 – 00146 Roma, or in telematic mode via TEAMS platform.

Candidates admitted to take the oral exam will be summoned, by the Department's Research Area, by letter sent by e-mail to the e-mails indicated by the candidates.
